

The Scoop on Dog Poop

Are you a good neighbor dog owner?

Do you want to help reduce environmental pollutants?

Here are some good reasons to Pick-Up after Your Dog:

- Dog poop is a major cause of water pollution. Your pet's waste causes nasty bacteria to enter into streams and seawater.
- When left on the ground, dog waste adds an excessive amount of nitrogen to the soil which increases the spread of nitrogen-loving weeds, often at the expense of native plants. The quickest, easiest way to get rid of a dog's poop is to put it in a plastic bag and the bag in a trash can.

Summary of Montgomery County's "pooper scooper" law:

Animal Defecation ("pooper scooper" law) (Montgomery County Code, Sec. 5-203(a)(2) An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director. Feces may be picked up in a plastic bag. If this bag is placed inside another plastic bag, it may be put out for disposal in your normal household trash. Penalty for Violation: \$100

The Brookeville Academy

The resident taxpayers of Brookeville own the Academy. They are invited to use the Academy only three times a year: Town picnic, Christmas Party, and yearly Town meeting.

The Academy is used primarily by non-residents as an economical rental property. The Town Government and paid staff spend most of their time upgrading this rental property to maximize rentals. This is lopsided and unfair to the residents of Brookeville.

The Academy could be used to benefit the resident taxpayers of Brookeville and rental of the Academy could be deemphasized. Is anyone interested in using the Academy for:

1. Archive for Documents
2. Museum for Brookeville Artifacts
3. Book Club
4. Garden Club
5. Discussion Club
6. Mother's Club

The Town Government and paid staff should also consider the resident taxpayers' needs and incorporate them into their governance of the Town. The Town needs to use the Academy in a way that benefits the Town residents and creates friendliness within the Town.

Using Our Brookeville Academy

Thanks to Harry Montgomery for visiting with the neighbors and sharing his thoughts about the use of the Brookeville Academy. His letter is reproduced here. We encourage you to share your thoughts with Harry, as well as the Commissioners, Academy Manager and Beyond the ByPass Task Force, which is discussing this issue. The Commissioners anticipate key input from that Task Force.

The Commissioners would like to clarify a few items:

Academy and Schoolhouse Operating Costs:

The Town's FY15-16 Budget includes over \$20,000 for the annual operating costs of the Academy and its grounds. There is also money budgeted for capital improvements to the Academy, including both interior and exterior upgrades such as new furniture and appliances, landscaping, and major repairs such as roof replacement. Please let the Beyond the ByPass Task Force know what improvements to the Academy will help meet Residents' needs. They are active in this conversation and will be presenting such recommendations to the Commissioners.

An additional \$20,000 is budgeted for repairs to the Schoolhouse due to moisture issues. Although it is typically open for Heritage Days, the Schoolhouse is currently unused, and is not a source of revenue for the Town. Therefore, we need to raise funds.

We have set an ambitious goal of \$15,000 in Academy revenue for the year. Our challenge is to determine how these resources can bring in more revenue and provide more enjoyment for renters and visitors without compromising the Town's interests.

Academy Uses:

Sharing these historic resources with Residents and outsiders benefits the Town and the buildings. The Brookeville Academy supports the local community by offering the facility at no charge to several local Scout troops, The Greater Olney News planning committee, the American Legion, and of course, the Bicentennial celebration. Non-profits also receive discounted rates for lecture series and other events. Some past events initiated by Town Residents include a MOMS Club seminar, local art show, and music lessons.

The Town hosts several annual events for Residents at the Academy. There is no barrier to having the other types of activities that Harry suggested - in fact a family movie night is already in the works. To our knowledge, the Town has not turned down any desired use by Residents inquiring about holding clubs and activities there. A Moms/Dads group? Sure - how do we make the Academy more comfortable for that kind of thing, if Residents want those uses? A Garden Club? Book Club? In a 50 household town with many commuters, is there interest? We welcome any use by Residents and encourage such interest; we simply haven't seen initiatives like Harry recommends.

As to archives: much of the Brookeville Town records are now at the Maryland Historical Society and the Sandy Spring Museum, where professional archivists organize the items for public access and ensure that everything is kept in the proper climate controlled conditions.

The Academy can certainly host a more visible repository of Brookeville history and commendations - how might we do that? Does the Town want the Academy open more? Should the public be invited to visit this historic building on a regular basis? Again, please bring your ideas to the Beyond the ByPass Task Force so that other residents hear your suggestions before the Task Force reports to the Commissioners and Town.

Academy Rentals:

The number of private rentals by Town Residents varies, but averages about 6 times per year, which equates to about 20% of the total rentals. Many of the non-resident renters are members of the greater Brookeville-Olney-Sandy Spring-Ashton community. Town Residents are always given priority over outside renters and pay a flat rate of \$125, compared to between \$175 and \$550, for outside renters.

The Commissioners see *both* use by Town Residents and use as a rental venue as important functions of the Academy; not as conflicts. Consistent with the results from the Survey Monkey earlier this year, we believe the Academy can bring in more revenue AND be more attractive for Residents' use. We hope that Residents will continue this important discussion in the Beyond the Bypass Task Force which meets again on Thursday, October 1st at 7:30pm. Their recommendations to the Commissioners will take into account the perspectives that Harry presents, as well as the current policy of reduced-rate rentals for Resident events, and marketing at full rates to outside renters.

Glyphosate Petition

In response to a petition generated by town residents concerned about the use of glyphosate ("Roundup") on Town property and rights-of-ways, the commissioners voted at the September 15th Commissioners meeting the following:

Cease the use of glyphosate for "general cosmetic purposes" (such as crab grass in gravel lanes, weeds in brick sidewalks, reduction of weeds on street margins) on Town property; strictly limit use to poison ivy/poison oak and similar plants. This change will take place in all future Town contracts.

MoCo Police Conduct Prescription Drug Take-Back Day Saturday, September 26 between 10 a.m. and 2 p.m.

On September 26, there will be drop-off locations throughout Montgomery County. These locations will accept prescription drugs and over-the-counter medications only. Liquids, illicit drugs, needles, sharps and syringes cannot be accepted as part of the take-back program. Officers will staff collection boxes in the parking lots or in the lobbies all Montgomery County Police Departments.

The Montgomery County law enforcement community is particularly interested in medications containing controlled substances but will accept any medications brought for disposal. All sites will take pills and medication patches of all kinds. If possible, prescription labels should be removed or personal information should be blacked out; however, pill bottles will still be accepted if the labels are attached. No questions will be asked. This is an opportunity to safely empty out a medicine cabinet of drugs that are no longer needed.

All the returned medications on Drug Take-Back day will be destroyed by the U.S. Drug Enforcement Administration.
