Brookeville ByPass Update

Please hold the afternoon (1:30-4:30) of Thursday, June 16th to attend the All-important "Mandatory Referral" hearing for the Rt. 97 Brookeville Bypass. Topics: Final Route for the ByPass & Conditions for the Construction

Further information on timing for the Brookeville ByPass will be available as the agenda is finalized. There is a County parking lot right behind the MNCPP building.

The Commissioners will receive and post on the Town Website the MNCPP "Staff Report" and agenda for June 16th. The Staff Report is prepared for the Planning Commission to give them background for the discussion, testimony, and eventual decisions/votes that they make. The staff's recommendations will address the ByPass route, the timing of construction, whether or not further study is required, and related information. Please watch for notice that the "Staff Report" is available, and read it before attending the meeting. [Letters are accepted, as well.](#)

This hearing is open to the public. We urge every household in Brookeville to send a member and consider writing a letter (particularly if you can't be there) reflecting your perspective.

The ByPass has been Brookeville's most important issue for decades. We are at the brink of the necessary final decisions

before construction begins. The Town has never gotten so far in the process. When we see the "Staff Report" compiled by MNCPP senior staff, we will all know what concerns and recommendations they are putting forth. At present, we can only speculate.

While there can be numerous observers for this hearing (public attendance is very important), there will be time limits and other restrictions on how many people may speak, and for how long. This is a formal hearing (televised, recorded and transcribed), and the decorum is specified. If you aren't able to speak, consider that you let your presence speak, as the Quakers say, when describing the power of "witnessing".

Out of this meeting will come the MNCPP's final recommendation to SHA regarding what route the ByPass should take, and we will learn whether or not there will be a delay in the construction of the ByPass.

Ash Tree Removal

Sadly, the beloved Ash Tree at the Brookeville Academy needs to be removed. The Town consulted with several tree experts and it has been determined the Ash Tree has structural deterioration throughout the trunk and limbs. Now considered a safety hazard, the tree will be taken down.

Pogo Tree Experts was the lowest bidder and was awarded the contract. The tree will be removed the latter part of May, after an emergency HAWP is issued.

Organic Lawn Care

The Town Commissioners approved a contract with A.I.R. Lawn Care for natural, organic lawn care at the Academy. A.I.R is a local Montgomery County company and was recommended by a Town Resident.

Burning on Private Property

Open burning of material is prohibited in Montgomery County except under certain circumstances. In these cases, a permit is required from the Department of Environmental Protection (DEP) and/or strict guidelines must be followed. Please refer to the link below for information about open burning in the County, including how to apply for a burn permit or file a complaint about illegal burning.

The following items may not be burned in the County at any time:

- Household trash
- Tires
- Construction debris
- Asphalt shingles and tar paper
- Leaves, lawn thatch, and garden trimmings
- Green brush and other fresh or dried plant life (except certain agricultural materials)
