War of 1812 Bicentennial

The Town Commissioners are organizing a committee to commemorate the Bicentennial for the War of 1812. The Town of Brookeville will be the central focus of attention in 2014, the bicentennial year when British troops burned the White House on Aug. 26, 1814 and President James Madison sought refuge in Brookeville, which became the nation's capital for one day. The committee will work with the Sandy Spring Museum and Heritage Montgomery on the project. It is too early for any specific plans or events to be announced.

EPA's Green Power Community Challenge

In response to EPA's nationwide Green Power Community (GPC) Challenge issued in September, 33 Green Power Communities are now collectively using more than 1.6 billion kilowatt-hours (kWh) of green power annually, equivalent to the carbon dioxide (CO₂) emissions from the electricity use of nearly 142,000 average American homes. EPA's GPCs are well on track to reach the Challenge's goal of doubling the total aggregate amount of green power used by EPA GPCs to more than 1.8 billion kWh of green power annually.

The EPA recently released its update of the GPC Challenge rankings. GPCs are ranked according to the two award categories: the community that has the highest green power percentage, and the community that uses the most kWh of green power. Brookeville, Maryland, has retained the top spot for highest green power percentage of total electricity use with a whopping 50 percent.

Winter Storms bring the potential for strong winds and significant snow accumulations.

Here are some tips to be safe and be prepared:

- Assemble an emergency storm kit. Include a battery-powered radio or television, flashlight, first-aid kit, battery-powered or windup clock, extra batteries, non-perishable food, manual can opener, bottled water, any necessary medications, and a list of emergency phone numbers.
- Maintain a supply of extra blankets.
- Ensure that all household members have a warm coat, gloves, hat and water-resistant boots.
- Make sure your home has a telephone with a cord or cell phone to use as a backup. Cordless telephones require electricity to operate, and won't work if there is an outage.
- Identify a place for emergency shelter in case of an extended outage. It is important that customers with special needs or their caregivers take responsibility to make arrangements ahead of time to prepare for potentially long-lasting power outages.

If Power Goes Out: call Pepco at **1-877-Pepco-62** (**1-877-737-2662**) to report outages – even if your neighbors may have already called. Pepco *strongly urges* everyone to follow these important safety tips:

- Stay away from downed lines and report them immediately by calling **1-877-737-2662**.
- Never attempt to remove trees or limbs from any utility line. Assume all objects touching a power line are energized.
- If using a portable generator during a power outage, always operate it outside. Do not operate a portable generator near doors, windows or in garages to prevent deadly carbon monoxide from entering the house.

Snow Removal

The Town of Brookeville contracts with a snow plowing service for North, South, Water, the eastern portion of Market and paved section of Church Streets. During a snowstorm, no plowing begins until an accumulation of 4 inches of snow has fallen on the streets. The Maryland State Highway Administration clears Georgia Avenue (Maryland Route 97) - the Town's High Street and western Market Street and Montgomery County does the same for eastern Market Street where it switches from Brighton Dam Road.

Those residents and businesses with abutting sidewalks are responsible for clearing their sidewalks, driveways and entrances within 24 hours of the end of a snowstorm. All residents are strongly encouraged to be good neighbors by clearing the sidewalks in front of their homes, as well as assisting those who may not be physically able to do so.

STREET LIGHTS

If you notice a Pepco street light that is out, please look for a metal strip on the wooden pole that has the pole number and report the location of the street light to the Town Clerk. If the wooden pole does not have a pole number, please report the location of the street light.

The Town also operates several cast iron ornamental street lights and 3 wooden ornamental street lights. These ornamental street lights do not have pole numbers. If you notice an ornamental street light that is out, please report the location to the Town Clerk.
