We recently lost a beloved member of our Brookeville family. Clyde Unglesbee was a member of what we have come to call the greatest generation. Spending just a few minutes with Clyde would be enough to see the qualities of greatness in him and the countless others of his generation. A generation that saw the economic and political collapse of their world. And their response was to come together and do what needed to be done. Their experiences fostered a lifelong commitment to family, business, and community. For Clyde and his generation, nothing was impossible.

Viewed in this light, it's no wonder that Clyde would grow impatient with a forty year struggle to build something as simple as a road, like the bypass.

Clyde was a forceful advocate for the issues important to him and his community. He would build his position on a foundation of historical context, facts, and logic ~ a quality lacking in so many of today's leaders. He understood and practiced the art of working with people; always respectful and tolerant of disagreement. Clyde knew that disagreement was part of the process. Clyde's response: Do more homework to bring the skeptics over to your side.

Clyde was always concerned about any hint of hurt feelings as a consequence of anything he said or did. A personal example - Clyde was not able to make last year's annual meeting because of health problems. He called me the night before the meeting. He was concerned that I might interpret as criticism from him, his absence at the meeting. That was Clyde, how could you not love him.

Over the past several months Clyde would give me names of people I should contact. He would have already spoken with them, paving the way for me. He would provide me a brief history of each person and why we should be reaching out. The part of Clyde that I saw was that of mentor. He knew so many people, so much history, and was such a valuable resource for all the commissioners who followed him. He will be missed.

We would like to express our deepest sympathy to his wife, Anna Unglesbee, and his brother Les Unglesbee (Jo).

### ***How to Dispose of / Recycle Electronics***

Take your consumer electronics to the Solid Waste Transfer Station for recycling. All Montgomery County residents and businesses may use the facility.

#### *WHAT IS ACCEPTED?*

- small electronic appliances
- calculators
- camcorders
- CDs and floppy disks
- CD players
- cell phones
- computers and computer-related products
- consumer electronics
- copiers
- cords and cables (including chargers)
- digital cameras
- electronic typewriters
- fax machines
- microwave ovens
- personal digital assistant equipment
- printers
- projection equipment
- scanners
- telephones
- small electronic toys
- televisions
- VCRs

All collected items are recycled.

Sorry, they do not accept videotapes in the electronics recycling program, but you can bring up to 3 TV's.

### ***How to Dispose of Household Hazardous Waste***

The Solid Waste Transfer Station also offers a Household Hazardous Waste program to Montgomery County residents with home-generated hazardous waste. Some of your household products may be considered hazardous materials. Improper disposal of these hazardous materials may harm the environment and/or human health.

#### *WHAT IS ACCEPTED?*

- Batteries containing nickel, cadmium, mercury, silver-oxide, lead or lithium. (Alkaline batteries may be put in with regular trash)
- Brake fluid and antifreeze (5 gallon limit)
- Car batteries
- Gasoline, gas-oil mixes, flammable liquids, unwanted fuels
- Fertilizers with herbicides
- Fluorescent light tubes and bulbs (compact fluorescent lights - CFLs)
- Herbicides
- Insecticides (Chlordane, DDT, Malathion, Sevin, Arsenic, etc.)
- Mercury containing items, e.g, thermostats and thermometers
- Oil-based paints (Latex paints are not hazardous waste)
- Paint thinners and solvents
- Other pesticides (used for control of rodents, fungi, snails, mites, etc.)
- Photographic chemicals
- Swimming pool chemicals
- Used motor oil, most other oils, hydraulic fluid, kerosene (5 gallon limit)

## Annual Town Meeting

The Commissioners presided over the Town's Annual Meeting May 13<sup>th</sup> at the Brookeville Academy. A handful of Town Residents came out to hear President of the Commissioners Michael Acierno State of the Town address. After a moment of silence to honor long time resident and former commissioner, Clyde Unglesbee, the Commissioners announced they would like to honor Clyde and his service to the Town at an appropriate time and ask residents for thoughts and ideas. If you have any suggestions, please contact one of the Commissioners.

Highlights of the meeting included:

- Update on the Brookeville Academy: new energy efficient HVAC; interior painting; and upcoming outlays.
- Tree maintenance
- Infrastructure maintenance
- Fiscal Year 2009-2010 budget

Also announced was the signing of a contract with Clean Current for 1 year, June '09 to June '10 at \$ .10127 per kWh, 100% wind power for the Brookeville Academy. The cost per kWh is lower than Pepco's current rates and will save the Town money while reducing its carbon footprint.

The Town Commissioners extended an invitation to the Annual Town Picnic to be held Sunday, August 23<sup>rd</sup>. More information about the Annual Town Picnic will be coming in the next few weeks.
