## Road Closures and Resident Parking Information for Bicentennial Events

During the Bicentennial events Georgia Avenue and Market St. will be closed to all traffic entering and leaving town. The closures will occur Saturday August 30 from 9 am – 7 pm and Sunday from 11 am – 6 pm. Georgia Ave. will be closed from Goldmine Rd. to Brookeville Rd. and Market St. will be closed from Bordly Rd. to Brookeville Rd. Brookeville Rd will be closed from Market St. to Oakley Cabin.

There is limited parking available for essential travel during road closures by Town of Brookeville residents at Longwood Recreation Center. You must have a numbered permit to use this parking; police will be checking. Please contact the Clerk at [clerk@townofbrookevillemd.org](mailto:clerk@townofbrookevillemd.org) **no later than Monday, August 25 to obtain a permit.** Permitted cars must be moved to Longwood BEFORE the roads are closed. Residents may also park a car at MMMC parking lot behind the Thrift Shop on Prince Phillip Dr. or Camp Bennett (off of Rt. 97 N just past Bordly Dr.) without a permit and travel by shuttle during the road closures. **Free shuttles** will run from 9 AM until 7:30 on Saturday and 11 AM until 6:30 on Sunday. **Cars must be moved before the closures. No cars may park on High Street or Market Street from Sat 9 am to Sunday 6 pm.**

**NO VEHICLES WILL BE PERMITTED INTO OR OUT OF BROOKEVILLE DURING THE ROAD CLOSURES.** Police will be blocking entrance to all vehicles except for those with numbered parking permits for Longwood Community Center who will be permitted to enter and leave Longwood and event personnel with parking passes from the Inn at Brookeville Farms **NO EXCEPTIONS WILL BE MADE. POLICE WILL BE STOPPING ALL VEHICLES.**
