
You are invited to attend an Information Meeting on Tuesday, September 29, 2015 hosted by the State Highway

The downed Pepco power line caused by a tree falling on Brighton Dam Road on July 30, 2015 caused a small fire in front of 207 Market Street. The fire burned with heat that melted the sandy bricks into glass pellets and made a hole in the sidewalk. The Town will be repairing the sidewalk in conjunction with the Academy walkway repair. Pepco has been contacted about reimbursing the Town for the repair cost.

## **Right of Way Street Tree Trimming**

The Town of Brookeville will be trimming trees and shrubs that block street signs, trees and shrubs that hang too low over sidewalks and streets, and trees and shrubs that limit visibility at an intersection.

Municipalities are under a general duty to keep the public rights of way under control for safety and visibility. Trimming trees and vegetation to improve visibility is one of the most effective ways you can enhance traffic safety in your neighborhood. Overgrown trees and shrubs endanger us all when they block our view of traffic signs, pedestrians, bicyclists, and motorists.

Pepco is also doing tree maintenance within the Town. Pepco's tree maintenance program is critical to the successful and safe delivery of electric service.

## **Glyphosate Petition Received by Commissioners**

A petition was submitted by Fred Teal, Jr. at the August 10<sup>th</sup> Commissioners Meeting. Numerous residents signed the document, which requests that the Commissioners "instruct contract personnel that glyphosate is not to be used on private property without owner's approval and to immediately cease the use of glyphosate for general cosmetic purposes." The Commissioners will hear public opinion on this matter at the September 15<sup>th</sup> meeting and vote on whether to enact a Town ban on use of certain toxic herbicides. ## **ROUNDUP – CHANGING VIEWS ABOUT SAFETY**

In view of the changing information about the impacts of using Roundup, I think the town should develop policy guidelines that reflect current research findings on the subject. A number of families in town have become concerned about the use of Roundup (chemical name glyphosate) for cosmetic purposes on the margins of the streets and lanes in town to kill weeds. A petition was presented to the commissioners recently with the names of 30 residents who expressed concern about the use of Roundup both by residents and contractors.

#### So, what's the problem?

Well, 15 years ago, the National Institutes of Health did a Roundup safety evaluation and risk assessment (<u>http://www.ncbi.nlm.nih.gov/pubmed/10854122</u>) and "It was concluded that, under present and expected conditions of use, Roundup herbicide does not pose a health risk to humans." However in March of this year, the World Health Organization's International Agency for Research on Cancer (IARC) concluded that glyphosate is "probably carcinogenic to humans" based on research work done since 2000 <u>http://monographs.iarc.fr/ENG/Monographs/vol112/index.php</u>

#### So what are some more facts and what do we do now?

Roundup® is touted as a safe, environmentally friendly and easy to use herbicide. It's also denounced as a toxic, hazardous chemical. Which is right? Are there any alternatives to using Roundup?

Alternative products exist which play the same role as Roundup® in weed management. Acetic acid, fatty acids, and essential oils can all act as herbicides.
