Governor Breaks Ground for the Brookeville ByPass

Standing in front of Salem United Methodist Church Governor Larry Hogan and Maryland Transportation Secretary Peter Rahn announced the start of the Brookeville ByPass on Tuesday, September 25, 2018. The new 0.7-mile, two-lane ByPass with



bicycle-compatible shoulders is expected to be complete by Fall 2021. The Brookeville ByPass is 60 plus years in the making, and many Residents doubted if they would ever see the start of construction.

SHA contractor crews will begin trimming trees and clearing the work zone along Brookeville Road and MD 97. Expect intermittent single lane closures on Brookeville Road weekdays, 8 a.m. to 4 p.m. and on MD 97, weekdays, 9 a.m. to 3 p.m. Weather permitting, this phase of work should be complete by the end of 2018.

Local Income Tax

The Town Commissioners are analyzing the current budget to identify ways to cut cost to keep the Town financially solvent. The Town is receiving a 60% - 70% reduction in income tax revenue due from the State compared to previous years - between \$54,000 - \$60,000 per fiscal year in income tax revenue, instead of the \$100,000- \$193,000 it has been receiving. The decrease in Income Tax Revenue is due to errors in calculations by the State Comptroller's office in the years between 2010 -2014, supposedly due to a coding error by summer interns.

The Commissioners will give a budget update at the Semi-Annual Town Meeting in January 2019.

Open Burning

From Montgomery County DEP

Some recreational burning is allowed under strict conditions. However, most **open burning without a permit is prohibited in Montgomery County**, and fines of \$500 per day may be imposed for open burning.

The following items may not be burned in the County at any time:

- Household trash
- Tires
- Construction debris
- Asphalt shingles and tar paper

- Leaves, lawn thatch, and garden trimmings
- Green brush and other fresh or dried plant life
