ROUTINE TOWN BUSINESS:

- **Minutes**: The January 14 and January 28 meeting minutes were approved.
- **Budget:** The budget was emailed before the meeting for review.

Open forum for Town Residents: no Town Residents were in attendance.

BPC: the BPC Chair addressed the Commissioners:

- Trees: The Commissioners were asked to consider
 - o a "tree replacement" ordinance
 - o appointing volunteer members to a "tree committee" to review all matters concerning trees in Town
- Parcel 770: The Commissioners were given a status update of this potential sub-division
- Accessory Apartments: BPC Chair asked Commissioner Daley to attend the Feb. 26th MoCo meeting on Accessory Apartments, which are allowed under the Town's zoning but currently not allowed in MoCo's zoning.
- Comprehensive Plan: BPC Chair is meeting with Rebeccah Ballo, Supervisor of the HPC Office, to further discussions regarding the Certified Local Government (CLG) grant application.
- 15 High: BPC working on permit approval for this property and a Use & Occupancy permit.
- **Small Cell:** the BPC took no action on the aesthetic guidelines to evaluate small cell applications within Town

TOWN OPERATIONS:

- **Trees:** The Town Clerk will draft a "tree replacement" policy for the Town Commissioners review at the next Commissioners meeting
- 309/311: The owner was given a 60-day abatement; property is subject to re-inspection on 4/1/2019
- **Semi-Annual Meeting**: Jan. 28th meeting was a success!
- **Rental Report:** Events Manager will offer the Cub Scout Leader a contract for \$40 per month rate until June 2019; after that, the Town's non-profit rates will be in effect.

TOWN PROPERTY

Roads: Senator Zucker has requested \$100K for road repairs on behalf of the Town; the next step is for the Governor to approve or decline this request.
