Proposed Construction of Four New Single-Family Houses

Plans to sub-divide 4.3 acres of land adjacent to the cemetery (Parcel 770) into 4 (four) lots and construct one home on each lot is still in development. The owner of Parcel 770 has submitted HAWP Montgomery County's Historic Preservation Commission (HPC). The HAWP approval process is pending due to incomplete information needed to make a decision. Once the HAWP is approved, the developer will submit a Preliminary Plan permit to the Brookeville Panning Commission.

- ✓ Water, one gallon of water per person per day for at least three days, for drinking and sanitation
- ✓ Food, at least a three-day supply of nonperishable food
- ✓ Battery-powered or hand crank radio and extra batteries
- ✓ Flashlight and extra batteries
- ✓ First aid kit
- ✓ Whistle to signal for help
- ✓ Wrench or pliers to turn off utilities
- ✓ Non-electric can opener for food
