Town is Awarded a Maryland Heritage Areas Authority Grant

The Town of Brookeville was awarded a grant of up to \$35,000 from the MHAA grant program to replace the roof on the Brookeville Academy. The grant will require a 50% match from the Town. The roof will be replaced with a metal standing seam roof estimated to cost between \$70K - \$80K.

The Town Commissioners are happy to report that Margaret Kay, a long time Market Street Resident, has accepted the offer to serve her community as a member of the BPC.

The State of Maryland entrusts local jurisdictions with land use planning authority. Article 66B of the Maryland Annotated Code enables the Town of Brookeville to guide growth and development for the Town.

Do you need a Permit?

The Town of Brookeville has been a Historic District since 1979 and is listed on the National Register of Historic Places. Exterior work requiring a HAWP (Historic Area Work Permits) from Montgomery County's Historic Preservation Commission (HPC) includes but is not limited to the following:

- New Construction
- Additions
- Grading and removing live trees greater than six inches in diameter
- Removing or enclosing porches
- Installing siding, shingle or masonry facing or other changes to exterior materials
- Replacing a window sash with a new sash
- Permanently removing shutters
- Adding, removing or changing architectural features, including size, shape, and placement of windows
- Painting or removing paint from masonry

Interested in seeing where your house is losing energy? The Montgomery County Public Library have thermal imaging cameras to lend out.

Thermal cameras allow you to inspect your home with infrared technology using your smartphone. Find insulation, heating, and water problems around your home using the phone attachment with the FLIR ONE app. Available for both Apple and Android devices. Android devices come with a USB adapter for older phone models.

Thermal Cameras can be borrowed from any branch, but the Olney Branch has a camera. You must have a valid MCPL card to borrow the camera.
