If you did any exterior work on your property this summer, you might be eligible for the Montgomery County Historic Preservation Tax Credit.

All properties within the Town's municipal boundaries are eligible for the Montgomery County Historic Preservation Tax Credit, regardless of the age of your home.

An inclusive but not an exhaustive list of eligible work:

- Approved exterior storm windows, doors
- Chimney flue lining and repairs
- Exterior painting
- One-time termite infestation treatment
- Repairing architectural trim or ornament
- Repairing roofs
- Replacing roofs in-kind
- Repairing windows
- Professional services (architects, color consultants, engineers)

Have a Black Walnut Tree?

The Maryland Department of Natural Resource is collecting black walnut. The black walnuts will be planted along creeks, rivers, and streams to provide shelter for wildlife and enhance water quality throughout the Chesapeake Bay Watershed.

Residents can drop off black walnuts – in bags, boxes, or containers – to Gambrill State Park in Frederick County until October 26. The Reddy Branch Stream Valley, a tributary of the Patuxent River, surrounds the Town of Brookeville. A closer option would be to transport your black walnuts to the Reddy Branch to provide food and shelter for wildlife.

New Patio

Boy Scout Teddy Lin, from Troop 759, installed a 10 x 10 patio at the Schoolhouse as his Eagle Project. The patio will be used as a gathering spot when there are functions at the Schoolhouse. The patio may be accessed by a mulch path the was created by Eagle Scout Jacob Weinberger last summer.

The Schoolhouse site improvements are part of the larger project to use the Schoolhouse in partnership with Heritage Montgomery. The next project will be the construction of a porta-potty enclosure fence. The enclosure would be locked when the Schoolhouse is not in use.

The Town has an MOU with Heritage Montgomery to use the Schoolhouse as part of an interpretive program that would focus on the Town Quakers in the early 1800s, with particular emphasis on their involvement with abolitionism and the Free Black population. The goal of forming a partnership with Heritage Montgomery is to:

- Preserve the Schoolhouse and make it a viable resource for Residents and public
- Put the Schoolhouse into use as an educational site as part of a school tour package and scheduled monthly openings
- Connect Brookeville to Woodlawn, Oakley Cabin, and the Sandy Spring area sites, telling the Quaker and the African-American story
- Make the Schoolhouse accessible and appealing by cleaning up the lot and providing signage and constructing a path along North Street
- Make site attractive by landscaping and providing a bench
- Preserve the site by making it a bird sanctuary
