The new 15-star flags have been hung around Town on their new 6-foot-long poles. The flags and poles were purchased with a grant from Heritage Montgomery. ## New Roof for the Academy

The Town has received permits from Maryland Historic Trust and the HPC for the roof replacement at the Academy. The next step will be to apply for a Town of Brookeville permit, which will be on the BPC's June 2<sup>nd</sup> agenda. The Town of Brookeville was awarded a grant of up to \$35,000 from the MHAA grant program to replace the roof on the Brookeville Academy. The grant will require a 50% match from the Town. The roof will be replaced with a metal standing seam roof estimated to cost between \$70K - \$80K.

## Paving of the gravel roads

The Town Commissioners continue to consult with the Planning Commission regarding the Town's side streets. The width of the gravel roads will be narrowed, and the management of water flow from rains will be addressed. The long-term cost of paving North, South, and Water Streets will be compared to the cost of maintaining a gravel surface. The Commissioners will seek feedback from Town Residents about this infrastructure project in the coming months.

## Primary Election - June 2, 2020

The Maryland 2020 Presidential Primary Election has been postponed to June 2, 2020. This election will be a "vote by mail" election. Ballots will be delivered by mail to all registered voters by mid-May. If registered, you don't have to do anything, and the ballot will be sent to your registered address.

If you are not a registered voter, register to vote by May 27 to cast your ballot on June 2 for the Presidential Primary. Voters can check their registration status by texting the word "check" to 77788, and if they are not registered, they can text the word "Vote" to 77788 to do so For more information, please visit: https://www.elections.maryland.gov/elections/2020/index.html
