

The Town of Brookeville is one of 157 municipalities in Maryland. Municipalities are a city or town that has written its charter (a set of laws) and can govern itself separately from the county. It is a formal government with legal authority to exist. The powers that municipalities and counties have been defined in the Maryland State Constitution. Citizens living in municipalities elect their own officials to pass ordinances (local rules), create a budget, and provide certain services and programs. Not all cities and towns have the same services. The citizens living in each municipality can choose the kinds of services they want to have.

Preliminary Timeline: Update to the Transportation portion of the Comprehensive Plan:

- August 3, 2021: Final Draft Plan review at the BPC meeting
- September 13, 2021: Town Commissioner to review the Final Draft Plan

B. Market Street Reconstruction Project (Brighton Dam Rd to MD97 intersection)

After L/KLA design plan is approved by the Town of Brookeville and permits are obtained, work will begin on Market Street. The project will include roadway removal, grading, and resurfacing. The goal of the project is to improve traffic safety for motorists, bicyclists, and pedestrians.

Preliminary Timeline:

September 2021: final streetscape design received from L/KLA

TBD: Civil engineer engaged for construction plans

TBD: Request for Proposal sent out

TBD: Construction begins

C. Gravel Road Improvement Project

The Commissioners applied for a HAWP (Historic Area Work Permit) for tar and chip (double chip seal) with "blue-stone" for North, South, and Water Streets.

Preliminary Timeline:

- July 2, 2021: HAWP submittal to HPC
- July 24, 2021: Finalize funding sources
- July 24, 2021: Contractor Selection
- July 28, 2021: HAWP Application on the HPC agenda for review and approval
- July 24, 2021: Finalize funding sources
- September 7, 2021: permit on the BPC agenda for review and approval
- September 13, 2021: permit on the Town Commissioners agenda for review and approval
- September 2021: obtain schedule of work and notify residents
- October 2021: Complete work
