Road Resurfacing Project

Weather permitting, the resurfacing of the Town's gravel/side roads will begin the week of April 25, 2022. The subgrade preparation work will take place for 2-3 weeks by LW Wolfe. After the subgrade work is completed, Russell Standard will lay the tar and chip overlay. For residents that elected to resurface their private driveways, the current plan is for the contractors to coordinate work activities at approximately the same times they are working on your respective roads. Details on specific dates and instructions will be forthcoming as the schedule is finalized.

The Town Commissioners would also like to announce an alteration in the original project schedule as outlined in the approved "Resurfacing Gravel Roads Revised Plan," dated December 17, 2021. Part of the scope of work outlined in this plan included realignment of Water Street by shifting the entrance approximately 4 Feet to the West, remove the concrete apron, narrow the apron, and extend the approved tar and chip surfacing for Water

Street to Market Street. While this work is still planned to be completed, it was decided that it would be best to postpone the realignment of Water Street effort later once the Market Street improvement project scope is finalized. The primary rationale is to make sure changes planned to improve the sidewalk, aprons and intersection of Market Street are considered in the realignment of Water Street.

The resurfacing of the gravel/side roads and associated resident driveways should be completed by the end of May 2022. The re-alignment of Water Street is expected to be completed by December 2023.

Town Election

On Tuesday, May 10, 2022, there will be an election for one Town Commissioner who will serve a two-year term beginning in June 2022. Bill Gaskill currently holds the seat.

A. Update to the Transportation portion of the Comprehensive Plan

B. Market Street Reconstruction Project (Brighton Dam Rd to MD97 intersection)

After the update to the Comprehensive Plan is approved by the Town of Brookeville and permits are obtained, work will begin on Market Street. The project will include roadway removal, grading, and resurfacing. The project's goal is to improve traffic safety for motorists, bicyclists, and pedestrians.

- TBD: Construction begins
