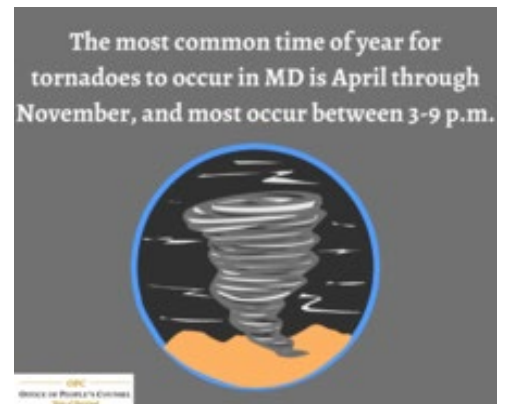
Once constructed, the newest address in Town will be 19, 21, 23, and 25 High Street.
