Commissioner Update

Garrett Anderson, of Water St., was appointed, confirmed, and sworn in as a Commissioner at the February 13, 2023, Commissioners Meeting. Garrett Anderson resigned from his elected seat as Town Commissioner on February 16, 2022, and will now serve the remainder of his term, which expires June 2023.

The Town once again has 3 Town Commissioners.

State of the Town

A Summary of the Semi-Annual Town Meeting

Town Residents joined the Town Commissioners and Staff via Zoom on Monday, February 6, 2023, to hear an update on the Town.

BPC Update

- Parcel 770: All plan approvals have been obtained by the owner; the easement agreement must be signed before the Town permits are released.
- 1 High St: The BPC has been working with the owner for the redevelopment of the site. The owner has a conditional HAWP, and we anticipate he will submit a Town building permit soon, along with the required Historic Use Permit and parking plan.
- Update to Comprehensive Plan: the updated Comprehensive Plan has been approved and is on the Town's website for public viewing.

Post-ByPass Era Plans

- The BPC has been in contact with Montgomery County and SHA about the ownership of High St and the western portion of Market St. At this point, SHA will retain ownership of MD97 through Town.

Parking Ordinance

- The ordinance is a work in progress. The draft ordinance will be reviewed by the Town's attorney before being posted for public review. A public meeting will be scheduled for public comments.

Town Infrastructure

Regular maintenance is being performed at the Schoolhouse and the Academy. This spring, a new layer of Tar & Chip will be applied to the Town's maintained roads.

YTD Operating Revenue is 51% of Annual Budget. Annual Revenue Forecast in line with FY23 Budget

YTD Operating Expense is 46% of Annual Budget. Items of note are the increase in expenses due to Fire Sprinkler replacement and the decrease in YTD expenses due to timing - Propane for example has a budget of \$8,500 and the Town only spent \$500 YTD.

YTD Capital Expenditures amount to \$5k. Capital Revenue - Grant Income of \$800k and expected Cap Expenditures of 1,114M are Budgeted but not incurred to show the Town project costs in future years.

Academy Receives a Lighting Upgrade

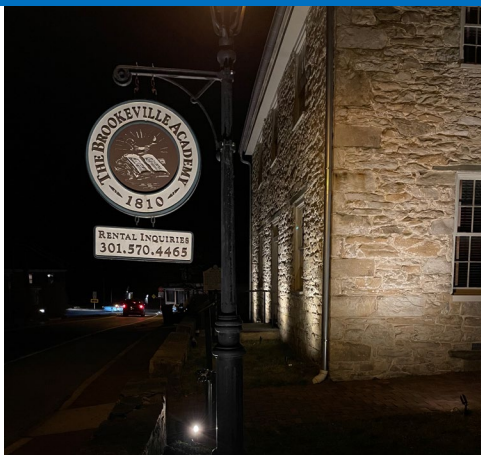
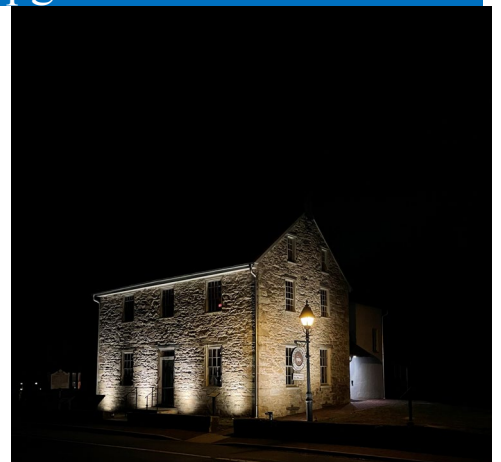

Post Bypass Era Plans

A. Market Street Reconstruction Project (Brighton Dam Rd to MD97 intersection)

The project will include roadway removal, grading, and resurfacing. The project aims to improve traffic safety for motorists, bicyclists, and pedestrians.

Preliminary Timeline:

- 2023: Design RFP and Design plans
- TBD: Civil engineer engaged for construction plans.
- TBD: Request for Proposal sent out for construction
- TBD: Construction begins (2-3 years out)

Montgomery County Historic Preservation Tax Credit

APPLICATIONS ARE DUE BY APRIL 1, 2023

Did you work on your home in 2022? If so, you may be eligible for tax credits through our Historic Preservation office! Eligible work includes repairs, restoration, or Preservation of exterior features of designated structures. The Town of Brookeville is listed in the Montgomery County Master Plan for Historic Preservation. All homes within the Town's municipal boundaries are eligible to apply for the Historic Preservation Tax Credit.
