### **Montgomery County and the War of 1812** Presented by Sandy Heiler

Montgomery County was never a battleground during the War of 1812. But its people were intimately involved in the war—some fought in it (and some fought against it, and some did both), some were wounded, some were captured, and some died. Montgomery's Quakers, who wanted nothing to do with war, provisioned the troops, because they were hungry. And they took hundreds of refugees, including the President of the United States, into their homes, because they needed shelter.

The talk begins with some context--the big political, social, and economic forces at work in 1812. It presents a big-picture view of what happened during the war focusing on the periods of greatest involvement by Montgomery Countians--in 1812, during what's politely called the Baltimore Newspaper War of 1812 (or less politely, the Mobtown massacre) and in 1814 during the events that surrounded the British occupation of Washington DC. The talk ends with what ultimately happened to the people involved, and the impact of the war on everyone.

## ByPass Update

The SHA reports that the project is now 85 percent complete. The previously communicated estimated completion date for the project was the year-end of 2022. The new estimated completion date is late summer 2023. The bridge redesign for the project pushed back the final paving schedule. Limited work on the project will continue through late spring, weather permitting.

An HPC permit and a Town of Brookeville permit are required for any tree removal greater than 6" in diameter. No permit is needed to plant a tree!

### **A. Market Street Reconstruction Project (Brighton Dam Rd to MD97 intersection)**

The project will include roadway removal, grading, and resurfacing. The project aims to improve traffic safety for motorists, bicyclists, and pedestrians.

- 2023: Design RFP and Design plans
- TBD: Civil engineer engaged for construction plans.
- TBD: Request for Proposal sent out for construction
- TBD: Construction begins (2-3 years out)
