Town Awarded a Heritage Montgomery Mini-Grant

The Town was awarded a Heritage Montgomery Mini-Grant of \$2,150. The grant money will be used to install a new sign at the corner of High & Church Streets to direct visitors to park behind Salem United Methodist Church. The sign will hang from a decorative bracket on a pole to match the cast iron streetlights. New street signs will also be mounted on the pole.

Awards for 208 Market St.

Miche Booz, a Town Resident and local architect, won two awards for the same structure at 208 Market Street. The first was a preservation award from Montgomery Preservation for the adaptive reuse of a 1920s concrete garage. The second was a 2023 Excellence in Design Award from the Potomac Valley Chapter of the American Institute of Architects. The award was for Miche's for the adaptive reuse of a 1920s one-car garage to create a charming, modern cottage. The site is a 10,000 sq. ft. corner lot behind the historic Isaac Briggs house in the Town,
