Annual Town Meeting Review

The Town's Annual Meeting was held on Wednesday, June 12, 2024, in person at the Brookeville Academy and via Zoom.

Here are some of the highlights from that meeting:

The last leg of the ByPass is scheduled to be open by July 1, 2024. The delay in opening that portion of the road is due to drainage issues. SHA will hopefully be taking down any unnecessary signage.

The draft Fiscal Year 2025 budget was viewed and discussed. The current year-to-date budget figures through April 30 were reviewed. The expenses are projected to be under budget for this fiscal year.

SHA is conducting a sidewalk feasibility study that will be completed on July 31, 2024. The goal will be to have sidewalks from traffic circle to traffic circle within the Town. The feasibility study will also have options to determine the realignment for the intersection of Water, Market, and High Streets. With the results of the sidewalk study, the streetscape project can move forward with a Request For Proposal (RFP) design and build plans for East Market Street.


Grants Procured


Maryland Historic Trust Grant

The Historic Preservation Capital Grant Program awarded the Town up to \$100,000.00 for the Brookeville Academy project. The project is an exterior renovation of the Academy to include, but not limited to, facade repointing, replacing the front door and hardware, caulking and painting the windows and trim, and rebuilding/repointing the wall.

Maryland Smart Energy Communities Grant

The Maryland Energy Administration (MEA) awarded a grant not to exceed \$25,067 for the replacement of fifteen (15) existing high-pressure sodium (HPS) town-owned streetlights with LED streetlights for improved energy efficiency and a reduction in light pollution. The fixtures will be changed from 70w HPS omnidirectional luminaires to 50w LED fully directional luminaires.








Parcel 770 subdivision
