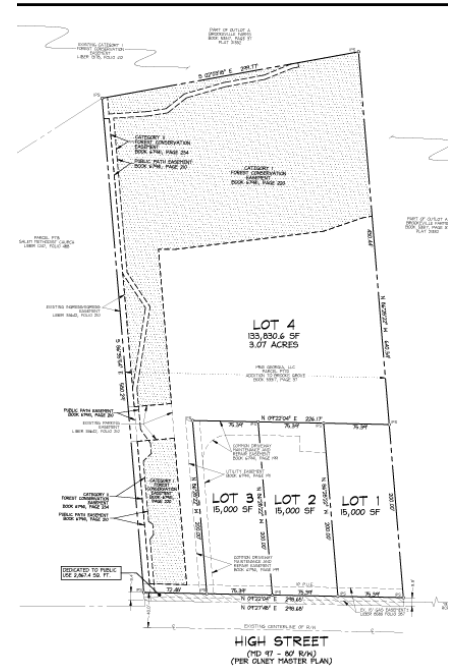
## News from the BPC

There are no permits or preliminary consultations on the May 6<sup>th</sup> BPC Agenda.

The BPC will discuss recent developments for building four new homes on High Street. The homes will be located on 4.3 acres of land adjacent to the cemetery. The building permits were approved at the July 12, 2022, BPC meeting and the subdivision of Parcel 770 was approved at the June 4, 2024 BPC meeting.

Once completed, the homes will have the following addresses:

- 19 High Street = Lot 4
- 21 High Street = Lot 3
- 23 High Street = Lot 2
- 25 High Street = Lot 1



## Infrastructure Updates

The new parking sign for the corner of High and Church Streets has arrived! The installation of the new sign will start the week of May 5 and, pending weather, the sign will be fully erect by May 15. The sign's purpose is to alert renters of the Brookeville Academy to park behind Salem United Methodist Church (SUMC). The Town pays SUMC annually for using their parking lot for the Town functions. The Town received a Heritage Montgomery Mini-Grant to help pay for the sign and installation.



The new LED light fixtures for the fifteen (15) cast iron street light poles throughout the Town have shipped, and installation will begin in late May. The LED light fixture will look similar to the existing ones. A Maryland Energy Administration (MEA) grant of up to \$25,067 was awarded to the Town for converting from converting from HPS (High-Pressure Sodium) to more energy-efficient LED lighting.

## Parking Reminders

As many of you know, our narrow gravel roads share vehicle and pedestrian traffic. The roads are designed to maintain the historic and rural village character of our Town. To facilitate safe access and emergency service requirements, we look for Town Residents to use courtesy and common sense and observe and comply with all parking laws.

Also, please:

- No Parking within 35 feet of an intersection/intersecting roadway
- No Parking within 5 feet of a driveway
- No Parking within 15 feet of a fire hydrant
- No Parking opposite to the flow of traffic (left wheels to the curb)
