The Town of Historic Brookeville is small—but not so small that we all know each other personally. You might recognize me as the woman in the axolotl onesie that one hot Halloween, the one waving at everyone, yelling at cars to slow down, or petting every dog in sight. Maybe you saw me hacking at tree limbs with a machete when I couldn't find a saw. However you know me—or don't—what matters is that I'm your neighbor. And whether or not you believe it, I really do care about you, your family, and your wellbeing.

You see, there are two ways to define a neighbor: someone who lives nearby, or someone who acts with care toward others. I'd like us to think more about the second. In a town like ours, proximity is a given. But neighborliness—building community, looking out for each other, setting aside differences for the greater good—requires intention.

My husband (you know, the guy with the villain moustache) and I love this Town. Though we didn't grow up in Brookeville, we grew up near it, and have been deeply moved by the welcome we've received here. We've made friendships that feel like family, and we try every day to pay that kindness forward, even as we continue to learn what it means to be good neighbors.

That said, there are things I struggle with here: the silence, the fear, the avoidance. I've seen bullying. I've seen people too afraid to walk down certain streets because of a neighbor. I've seen folks go to commissioners before simply knocking on a door or starting a conversation. That's not the kind of neighbor I want to be—or the kind of community I want for our kids.

In my professional life, I help people start and hold hard conversations. They're never easy, but they're necessary. The hardest part is just beginning; coming to the table with the belief that the person across from you wants good things too. Sometimes we'll be disappointed—but we must try first. Then call the commissioners, if needed, but lead with faith in your fellow man.

I don't expect this article to change everything. But I hope it gives us all a moment to pause and reflect on what it means to be a neighbor—not just by address, but by action. Our human need to be seen and heard is universal. As a therapist, I know that bullying often masks that need. As a neighbor, I can't accept bullying as part of our community.

There's always room at my table—for disagreement, for learning, for growth. I won't ever "other" anyone. My hope is that we each consider how we can make room at our own tables—for difficult conversations, for curiosity, for vulnerability—so we can continue to build the kind of Town we all deserve to call home.

Flags Are Flying in Brookeville

Our streets look spectacular with our 15-star flags waving in the wind. The flags will fly until Veterans Day.

The Town of Brookeville flies the 15 Star, 15 Striped flags authorized by the Flag Act of January 13, 1794. This flag was the only American Flag to have more than 13 stripes. Congress changed the flag design with the Flag Act of 1818, which returned the flag design to 13 stripes and 20 stars for the 20 states.

Infrastructure Updates

What items are not accepted in bulk trash?

- Propane Tanks
- Uncovered glass mirrors/tabletops
- Debris generated from major construction, remodeling, demolition, or repair work like bricks, concrete, lumber, non-metal fencing, shingles, drywall, paint, rock, sod, auto parts, tires, non-metal kitchen cabinets, sheds, large dog houses, etc.
- Dirt, yard debris, rocks, tree trunks
- Hazardous materials
- Human or animal fecal or uriniferous matter; infectious waste; dead animals
- Sizable items that will not fit in the dumpster
