Remembering Buck Our Neighbor and Friend

Robert Taylor "Buck" Bartley, Jr.
1938 - 2025

A longtime resident of Church Street, Buck was elected on May 13, 2014, to serve as a Town Commissioner and resigned his position for personal reasons in January 2018. Buck joined the BPC in April 2020, bringing decades of construction experience and common sense.

The Town had a memorial gathering on Sunday, July 27, to share memories and celebrate the impact he had on our lives. Here is an excerpt from the moving eulogy from Michael Acierno that summed up the sentiments for all who gathered:

"Buck was an outstanding example of what it means to live in the historic village that is Brookeville. His concern for all his neighbors and his commitment to protecting Brookeville's place in history were unbounded.

One doesn't simply own a house in Brookeville. Buck understood better than many that by choosing to live here, we agree to accept the responsibility of preserving and protecting this historical legacy of more than 200 years. We are just custodians making sure we leave to the next generation the legacy that was left to us by previous generations."

We will miss you, Buck.

At the August 5th Brookeville Planning Commission (BPC) Meeting, the following items will be on the agenda:

Permits for Approval:

- a. 19, 21, 23 & 25 High Street: site development

The sub-division of Parcel 770, the 4.3 acres of land adjacent to the cemetery, created four building lots, and the building permits were approved at the July 12, 2022, BPC meeting. The permits expired after two years, and


revised house designs to reflect the updated Montgomery County building code requirement will be submit at a later date for the house and accessory structure construction after HPC approval.

On June 4, 2024, the BPC approved the subdivision of Parcel 770, creating the following home site with these addresses within the Town:

19 High Street = Lot 4
21 High Street = Lot 3
23 High Street = Lot 2
25 High Street = Lot 1

The BPC will also be reviewing a proposed community playground plan to be built at the site of the old playground at Salem United Methodist Church (SUMC). The Town plans to partner with SUMC to apply for a Community Parks and Playgrounds Program Grant from the Maryland Department of Natural Resources. The project needs local planning review to ensure the project is compatible with our Comprehensive Plan.
