An informal written request may be submitted to the Supervisor of Elections and must include:

1. Voter's name
2. Residence address
3. Address where the ballot should be mailed (if different)
4. Voter's signature

**Resident Rental Rate: \$150 flat rate.** This rate applies **regardless of the number of rooms, hours of use, or day of the week.**


A **refundable security deposit** is required for all rentals, including resident rentals, and must be submitted in advance of your event.

## Parking Reminder for Brookeville Residents

Our narrow gravel roads are shared by vehicles and pedestrians and are intentionally designed to preserve the historic, rural character of our Town. To maintain safe access for all—and to ensure emergency vehicles can reach every home—we ask residents to use courtesy, good judgment, and comply with all parking laws.

### **Please remember:**

- No parking within 35 feet of an intersection or intersecting roadway
- No Parking within 5 feet of any driveway
- No Parking within 15 feet of a fire hydrant
- No Parking opposite to the flow of traffic (left wheels to the curb)
